

## **WENCO® LIMITED WARRANTY**

### **Components**

Subject to the conditions and restrictions contained herein, WENCO guarantees and warrants that each JX-7 product shall be free from all defects in materials and workmanship for a period of one (1) -year from the date of its installation. Should a component part be proven to be defective, WENCO shall, at WENCO's option, either furnish a replacement, without charge and shipped freight prepaid, for the defective component or refund the purchase price of the defective part. In no event shall WENCO pay for the cost of labor or installation of either the original JX-7 product or any replacement part.

This warranty does not cover (1) component parts which have been damaged by accident, mishandling or improper use, (2) component parts which have been subjected to negligent operation, (3) screen or glass, (4) damage resulting from improper installation, or (5) damage caused by fire, flood, act of God, earthquake, storm, tornado, or any other cause beyond the control of WENCO.

This warranty sets forth WENCO's maximum liability for its JX-7 products. WENCO SHALL NOT BE LIABLE FOR INDIRECT, CONSEQUENTIAL, INCIDENTAL DAMAGES. WENCO MAKES NO OTHER WARRANTY EXCEPT AS CONTAINED HEREIN WITH RESPECT TO ITS JX-7 PRODUCTS. THE DURATION OF ANY IMPLIED WARRANTY SHALL BE THE SAME AS THAT OF THE EXPRESS WARRANTY STATED HEREIN.

Service under this warranty is available by contacting WENCO or one of its authorized distributors, as soon as practicable after discovery of a defect, but no later than one year after installation. WENCO reserves the right to have any JX-7 product, alleged to be defective, field inspected by a WENCO representative. No distributor, dealer, or representative of WENCO has the authority to change or modify this warranty, either orally or in writing, in any respect.

### **Insulated Glass**

Subject to conditions and restrictions stated herein, WENCO guarantees and warrants that each WENCO Insulating Glass Unit shall be free from any material obstruction to vision due to film formation or dust collection on the interior glass surfaces resulting exclusively from failure of the hermetic seal, other than through glass breakage for five (5) years from the date of its manufacture.

For any unit failing to comply with this warranty, WENCO will ship a replacement unit without charge to the shipping point nearest the installation. This warranty shall not apply to a replacement unit beyond the five (5) year period applying to the original unit. THIS SHALL BE WENCO'S MAXIMUM LIABILITY UNDER THE WARRANTY, AND WENCO MAKES NO OTHER WARRANTY OR GUARANTEE, EITHER EXPRESSED OR IMPLIED. ANY FURTHER CLAIMS DUE TO SPECIAL, INDIRECT, CONSEQUENTIAL, OR INCIDENTAL DAMAGE ARE EXCLUDED FROM THIS WARRANTY.

This warranty shall not apply to units used outside the continental United States, or to units damaged in handling or in installation. This warranty shall also be void if the unit is subjected to stresses resulting from localized application of heat, which causes excessive temperature differentials over the glass surfaces or edges, excessive vibration, a movement of building or foundations, or if it is installed over four thousand (4,000) feet altitude.

WENCO reserves the right to have any unit, alleged as being defective under this warranty, field inspected by a qualified factory representative and returned to the factory. No distributor, dealer, or representative of WENCO has the authority to change or modify this warranty, either orally or in writing, in any respect.
